



NATIONAL REPRESENTATIVE'S CODE OF CONDUCT

1. PURPOSE

- 1) Chinese Taipei Touch Association ("CTTA") is committed to promoting and developing touch football in Taiwan (ROC). To do so, representative players, being the public face of Touch Football in Taiwan and subsequently subject to greater scrutiny, must maintain CTTA's core values and good reputation.
- 2) This policy is in addition to [CTTA's Code of Conduct](#) and have been adapted from [Federation of International Touch \(FIT\) Code of Behaviour](#).

2. SCOPE

- (1) This Code applies to National Representative of Chinese Taipei Touch Association.

3. RESPONSIBILITIES OF NATIONAL REPRESENTATIVES

- (1) A National Representative must:
 - (a) At all times behave in manner that promotes and upholds the highest standards of integrity, dignity, and professionalism;
 - (b) Demonstrate a positive commitment to the rules of touch and CTTA's programmes;
 - (c) Be a role model at club sessions and a credit to the national programme;
 - (d) Display a commitment to trainings;
 - (e) Abide by any relevant national & Federation of International Touch anti-doping rules and policies that are relevant at the time;
 - (f) Respects opponents, officials, teammates, management, and any personnel involved in CTTA;
 - (g) Comply with team protocol and procedures that any duly appointed national coach shall impose;
 - (h) Act in a manner that is in the best interest of the team;
 - (i) Respect the law and customs of the countries he/she visits; and
 - (j) Staying appreciative of community efforts and support, and to give back to the community.
- (2) All National Representatives must sign the Declaration of Commitment as described in the Schedule.

4. DISCIPLINARY SANCTIONS

- (1) A CTTA administrator (director or supervisor) may enforce the terms of this Code if a National Representative has infringed this Representatives Code.

5. SOCIAL MEDIA AND THE INTERNET

- (1) The use of social media and the internet in relation to touch football in Taiwan (ROC) should be always respectful and appropriate.

- (8) To comply with team protocol and procedures that my coach(es) shall impose;
- (9) To act in a manner that is in the best interests of the team;
- (10) To respect the law and customs of the countries I visit; and
- (11) Staying appreciate of community efforts and support, and to give back to the community.
